**THE CONSTITUTION OF ANGUILLA
PROCLAMATION**

(SUMMONING THE FIRST SESSION OF THE TWELFTH ASSEMBLY)

GREETING

IN THE NAME OF HER MOST EXCELLENT BRITANNIC MAJESTY ELIZABETH II, by the Grace of God, of the United Kingdom of Great Britain and Northern Ireland and Her Other Realms and Territories, Queen, Head of the Commonwealth, Defender of the Faith.

WHEREAS the Eleventh Anguilla House of Assembly was, on the 9th day of May, 2020, dissolved by Proclamation in the Official Gazette published in accordance with the provisions of section 63(2) of the Constitution of Anguilla contained in the Anguilla Constitution Order 1982 (as amended) and following the said dissolution, Monday, the 29th day of June, 2020 was by further Proclamation appointed to be the date and time for a general election of the members of the Assembly.

AND WHEREAS a general election of the members of the Assembly was held on the 29th June, 2020.


AND WHEREAS it is provided by section 62(1) of the Constitution of Anguilla aforesaid that the sessions of the Assembly shall be held at such places and begin at such times as the Governor may from time to time by Proclamation appoint.

AND WHEREAS after polling in a general election it is expedient that the Assembly should be summoned at a place and time for the First Session of the Twelfth Anguilla House of Assembly therefor duly appointed:

NOW THEREFORE, I, TIMOTHY JOHN FOY, OBE, Governor of Anguilla, in exercise of the powers conferred upon me by section 62(1) of the Constitution aforesaid, acting in my own deliberate judgment, **HEREBY SUMMON THE TWELFTH ANGUILLA HOUSE OF ASSEMBLY** and do further **APPOINT** Friday the 17th day of July, 2020 at 2 o'clock in the afternoon, at the Parliament Building in The Valley, Anguilla, as the time and place at which the First Sitting of the First Session of the Twelfth Anguilla House of Assembly shall be held for the due dispatch of public business and the said First Session shall accordingly commence.

AND ALL Her Majesty's officers and loving subjects in Anguilla and all other persons whom it may concern are hereby required to take due notice hereof and to govern themselves accordingly.
